The Transportation Department will have an open house at the Huron Arena from 7:00 am-7:00 pm on July 21st and will be at the Kindergarten screening that is held the first week of school, to answer any questions that you may have and to hand out the bussing assignment sheets for those students that have been registered for bussing by the May 12th deadline. Registrations that are turned in after July 21, 2025 will not have bussing information available immediately. It may take up to 15 working days for your child to receive a bussing assignment.

A ZPass parent/guardian ID agreement form has to be filled out, signed, and returned to the Transportation office if you have <u>not</u> signed an agreement form for your student(s).

Each Huron Public School Student, from kindergarten through 5th grade, that utilizes the school bussing service, will be issued a ZPass card that they will be <u>required to scan each and every time that they get on or off of all buses.</u> The ZPass card is good from year to year so please make sure to keep track of the ZPass for your student to use again the next school year. The ZPass and its use is required for all kindergarten through 5th grade students that ride the school bus unless a Waiver of Liability and Hold Harmless Transportation Agreement has been signed.

The ZPass provides the School District, specifically the Transportation Department, a way to see what bus your student either boarded or disembarked, the location of the bus at the time of the scan, and the time the student's ZPass was scanned. This information is needed by Transportation for two reasons. The first being that this information provides us with a real time roster of which students are on each bus at any given time. This information is a must have for the District in the case of a bus being involved in any type of emergency. Whether it be a crash or any other active threat on the bus. We have to know who is all on the bus so that we can contact the parents in these cases. This roster can also be used to supply law enforcement and other first responders with the number of people on the bus at the time of an incident. The second scenario in which the ZPass information is critical is if a student does not show up at home, daycare, or school. The information that is tracked by the ZPass scan provides Transportation the location that the student either got on or off of the bus so that we have a beginning point to start our search for the student as well as to be able to notify law enforcement of the student's last known location. This information enables us to cut down the amount of time that it takes to locate a child that has become lost. The minutes that we save could mean the difference to your student's safety. If parents register their child's ZPass with Zonarsystems.com, MyView sends this same information to the parent(s) either by a text message or email.

The ZPass that your student will be, or has been, issued is valid throughout their enrollment with the Huron School District. The ZPass is good for every year that your student is in school.

The use of Zonar's ZPass is helping the Huron School District provide the safest and most secure transportation possible for your child

The ZPass is **required** for every student kindergarten through fifth grade that utilizes the school bus for transportation. The only exception to this is if the parent(s) has signed a Waiver of Liability and Hold Harmless Transportation Agreement.

It is mandatory for every student to scan their ZPass every time that they get on and off of all buses.

Failure to comply with this rule will result in the following consequences:

1st conduct = warning

2nd conduct = 1 day suspended from the bus

3rd conduct = 2 days suspended from the bus

4th conduct = 3 days suspended from the bus

5th conduct = 4 days suspended from the bus

Keeping track of the issued ZPass is the responsibility of the student. Any student needing a replacement ZPass should **immediately** notify their bus driver and the school office. The cost for a replacement ZPass is \$5.

1.	Student rider has received the ZPass ID card with the ID Card Number listed above.
2.	Student will use the ZPass Id Card for the sole purpose of electronically identifying themselves as the person embarking/disembarking from a school bus if equipped with a ZPass reader.
3.	If the student suspects or discovers that the ZPass Card has been lost or stolen, he/she must notify the Bus Driver and the Parent/Guardian must get a replacement card as soon as possible. Unless otherwise specified by the Bus Driver, riders shall keep the ZPass Card within their sole possession and control, and shall not allow any other student to use it.
4.	If the student does not have his/her ZPass card when boarding a bus, they will not be denied boarding. However, repeated occurrences will result in suspension of bus privileges.
5.	Special needs riders may have their ZPass Card swipes administered by the attending Bus Driver.
6.	Lost and/or damaged cards will be subject to a \$5 replacement fee. A new ZPass may be requested by contacting any school office or the Transportation Department.
7.	Parent/Guardian may request a copy of this agreement to retain for their own records.

Huron Public Schools Bus Conduct—Parent /Guardian Agreement

Parent/Guardian understands, acknowledges and agrees to the following representations and responsibilities to the Student Conduct on School Buses.

- 1. Students are expected to discipline themselves and comply with the instructions of the bus driver. The driver will be in full charge of the bus and the passengers.
- 2. There must be no disturbances of any kind that might distract the driver and imperil the safety of the passengers.
- 3. When a child is riding, boarding, or leaving the bus, the bus driver has supervisory control over the student.
- 4. The bus is an extension of the classroom, students are required to conduct themselves on the bus in a manner consistent with established standards for classroom behavior.
- 5. Children who do not follow the Rules of Conduct or direction of the bus driver or other supervisory personnel on the school bus or transfer area may have their riding privileges suspended. Should bus privileges be suspended, the parents of the children involved become responsible for seeing that their children get to and from school safely, as the suspension is for all buses that they ride. Not just the bus that wrote up the conduct.

Students will observe the following rules while riding school buses:

Bus Riding Rules

- The bus Driver can and will assign seats at <u>ANY</u> time.
- Always follow the instructions of the Bus Driver and be respectful.
- Alcohol, tobacco products, vape devices, or weapons are NOT ALLOWED.
- Students must stay on their seats in their seats. <u>Standing will not be tolerated.</u> All body parts & Objects must stay inside the bus.
- Hands to yourself at all times. Always be respectful to others & their space.
- Fighting, punching, kicking, pushing, tripping spitting WILL NOT BE TOLERATED!
- English should be spoken while on the bus.
- Screaming and yelling are not allowed. (You MUST use your classroom voice while on the bus.)
- All garbage must go into the trash buckets. Eating and drinking are not allowed.
- Any damages/vandalism to the bus will be paid for by YOU.
- Throwing objects is NOT allowed.
- ZPass must be scanned every time.

CONSEQUENCES

Any violation of the rules can result in suspension or revocation of bus riding privileges as well as in-school consequences.
