## New Business

Motion by Wheeler, second by Yost, to amend the motion to approve the agreement with Koch Hazard Architects to conduct a facility master plan. The amendment is to place a \$10,000 cap on the cost of this study. The motion to amend the motion passed unanimously.

Motion by Halbkat, second by Bennett, to further amend the motion to approve the agreement with Koch Hazard Architects to conduct a facility master plan. The second amendment places emphasis on developing plans for the elementary schools first followed by the middle school, high school and district offices.
